#### **Regular Meeting April 19, 2014 Polk Business Center Meeting Room**

### MINUTES

- AQUATIC PLANT CONTROL: (Loren Johnson)
  - Everything is going along as planned.
  - Haven't done the update to the 5 year plan, will be working on that with Amy
  - When the spraying gets done, everyone can ride with and see how it works.
  - Per DNR they would like grab samples right after they spray.
  - Follow-up will be done after the spraying. Would like Kevin Wagner to do it again if it works with his schedule, if he can't we will need a backup plan.
- CLEAN BOATS CLEAN WATER: (Carl)
  - April 29<sup>th</sup> will be training at Unity school with help from LAWRD Staff. (10:30-11:30)
  - 20 students have expressed interest.
  - We will schedule various times covering the 4 public landings as in past years.
  - Landing Blitz is July 4<sup>th</sup> and will distribute ice packs.

# • PUBLIC APPOINTMENTS:

# ASSUMPTIONS

- BARR 2011 and USGS 1992 are valid sources of hydrology and water quality.

# TIME FRAME

- East Balsam is not fully mixed for dissolved oxygen during the summer months.

# **ISSUES**

- Shallow
- High Retention time
- Separate from the lake
- Little to no flow
- Anoxic conditions near bottom
- Soil phosphorus loading

# **OPTIONS DISCUSSED:**

1) Dredging

- 2) Flushing by Weir
- 3) Flushing by pumping
- 4) Aeration
- 5) Alum capping

# DREDING

- Dredging is the removal of the top sediment layer by mechanical or hydraulic means.
- Removal of the bottom soil layer includes the life sustaining soil of the lake.
- It would cost anywhere from \$18 to \$36 million.

# FLUSHING BY WEIR

- Flushing is recognized technique to improve water quality.
- We could use Harder creek, Otter creek, and lower Rice creek water diverted from its natural alignment to move south under Highway I.
- Culvert would need to be constructed under existing Highway I to pass the redirected flow.
- Flow during the summer is not a reliable source.
- Cost considered not feasible

# FLUSHING BY PUMP AND PIPE

- It would require taking from The Stumps to the northern edges of East Balsam where the flow would be able to interact with a larger portion of the lake before exiting through Big Narrows into Balsam Lake.
- This would require removal of the entire lake within 6 days.
- Construction of inlets and outlets will cause significant suction and jetting velocities at the entrance and exit.
- Would require cordoning off areas of Stumps bay and northern East Balsam from human and boat access.
- The high velocities surrounding the inlet and outlet may overpower fish near the suction flow and cause erosion in the lake bottom near the inlet and out lets.
- This very costly. (\$50 Million)

# AERATION

- This pumps and perforated hoses/pipes to force air into the bottom layers of the lake.
- It would increase the oxygen concentrations in the anoxic layer of the lake during the summer months.
- It is feasible option to reduce blue-green algae growth.
- Another aeration method is forced mixing through mechanical lift devices.
- Depending on the type of algae present in East Balsam aeration or forced mixing may be a viable alternative.
- Would need to do more research on this.

# ALUM CAPPING

- Placing alum into a lake.
- Not very effective in shallow lakes with significant external phosphorus loading.

# RECOMMENDATIONS

- It is recommended that none of the potential solutions be implemented as engineered solutions to East Balsam Lake water quality issues.
- Aeration and Alum capping could be investigated further by a limnologist.
