Regular Meeting December 21st, 2013 Polk Business Center Meeting Room

MINUTES

CALL TO ORDER: The meeting was called to order at 8:30 a.m. by Ray Sloss.

COMMISSIONERS PRESENT: Howard Seim, Caroline Rediske, Carl Holmgren, Ray Sloss, Dave Wagner and Loren Johnson.

APPROVE AGENDA: A motion was made by Howard Seim and seconded by Caroline Rediske. Approved.

APPROVE MINUTES: A motion was made by Caroline Rediske and seconded by Howard Seim to approve the minutes from November 16th, 2013, 2013. Approved.

• Bill Mork commented on the water quality in East Balsam and offered his support to clean it up.

Review of the bids with primary discussion regarding CLP Treatment and performance received in 2012 and 2013. The 2012 treatment (55.9 acres) resulted in major die off of all vegetation, and 2013 treatment (13.4 acres) with no results. Following a lengthy discussion of all bids received and references provided; a motion was made by Ray Sloss and seconded by Howard Seim to accept Clean Lakes Inc. bid for 2014 Herbicide Treatment. Approved.

4. **Inspection and Mapping**: One bid received from Endangered Resource Service, LLC.

Following review of the bid received and additional proposal for a full lake point-intercept survey (last one done in 2009) that would also include CLP bed mapping; a motion was made by Carl Holmgren and seconded by Caroline Rediske to approve proposal received and include the point-intercept survey. Approved

Items Approved:

• Pre-Post herbicide application surveys in the CLP identified treatment areas (\$2,425.00).

- Full lake survey that includes the complete CLP bed mapping prior to natural CLP senescence in late June (\$5,850.00).
- Complete five monthly surveys of the lakes four improved, two unimproved, and one private landing for exotic species from June October (\$600.00).
- Provide Navigational Trail Assessment (\$325.00 per visit) on an 'On Call' basis.

REVIEW NEW ACTION ITEMS:

Ray updated current list and will have available for next meeting.

ADJOURN: There being no further business, a motion was made by Loren Johnson and seconded by Caroline Rediske to adjourn the meeting at 11:15 a.m. Approved.
