- Special meeting Carl will read the resolution
- A motion was made by Tom Kelly and seconded by Howard Seim to accept the resolution by the BCPL. Approved.

- 1St and 3Rd Thursday the BLCP meet to review loan applications
- April 7th cut check with purchase order for the first 1/3 payment less \$10,000 that was forwarded by Carl Holmgren.
- May 6^{th} send in the rest of the 1/3
- June 6th balance of the harvester and equipment would be due
- We may miss the CLP but should have it by July for navigational

ACTION ITEMS:

- Ray will check with paper works to see if they can work with us.
- Tom Kelly will also check with someone that he knows.
- We need to have a 14 day notice out to the electors (goal to mail by March 1st)
- Ballots will be printed on colored paper.
